### 4. FIRST AID MEASURES

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

Provide adequate ventilation during heat welding. Work boots and work clothing recommended. Sunglasses that filter out UV light are strongly recommended since the white surface is highly reflective to sunlight. White surfaces reflect heat and light. Wear suncreen if on roof.

**Hygiene measures:** Keep away from food, drink and animal feeding stuffs. When using do not eat, drink or smoke. Wash hands prior to eating, drinking or smoking. Avoid contact with clothing. Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of dust. Ensure that eyewash stations and safety showers are close to the workstation location.
