# 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** No first aid measures normally required. However, if inhalation has occurred and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists more about 30 minutes seek medial advice.

**Skin Contact:** Quickly and gently blot away excess liquid. Wash gently and thoroughly with warm water (use non-abrasive soap if necessary) for 10-20 minutes or until product is removed. Under running water, remove contaminated clothing shoes and leather goods (eg. watchbands and belts) and completely decontaminate them before reuse or discard. If irritation persists, repeat flushing and seek medical attention.

**Eye contact:** Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 15 minutes oruntil the product is removed, while holding the eyelids open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention immediately. Take special care if exposed person is wearing contact lenses.



**Ingestion:** If swallowed, do NOT induce vomiting. Wash mouth with water and contact a Poisons InformationCentre or call a doctor.

### SMALL SPILLS

### LARGE SPILLS

# 7. HANDLING AND STORAGE
